



Once again, Fairfax Club Estates Home Owner Association (FCEHOA) is pleased to extend an invitation to you to join our pool for the 2015 Summer Season. The pool is being prepared for your summer use as we speak!

Your membership to FCEHOA pool entitles you and any member of your immediate family that lives with you during the summer to enjoy use of the pool, to include reserving one of the two pavilions for use for a party during normal pool hours (call the lifeguards to schedule a pavilion). Also included is the Annual Adult Social – free of charge (there is a charge if you are going to drink adult beverages provided).

You may also reserve the pool after hours for a private party (you must pay for the lifeguard salaries and comply with Fairfax County noise ordinances). CRYSTAL AQUATICS will provide personnel outside of the normal operating hours. The cost for said personnel will be at the prevailing annual rate and verified when you reserve the pool. The current rates (subject to change) are as follows: \$29.00 per hour for the operator, and \$21.00 per hour per lifeguard. The Pool Manager or Assistant Manager has the authority to approve or disapprove a request to keep the pool open after hours based upon available staff.

Crystal Aquatics also offers private swimming lessons and group swimming lesson. See the Pool Manager for details and costs (these are not included in your Summer Membership).

The price for the 2015 membership is \$488.00 (small \$10 increase from last year). Use the attached Registration Form or go to <http://www.fairfaxclubestates.org/pool>, scroll down to the **Fairfax Club Estates Summer Members** section, click on the word APPLICATIONS, download the registration form, fill it out, and write a check for \$488.00 made out to Fairfax Club Estates. Mail your check and forms to Fairfax Club Estates HOA, Fairfax Club Estates, c/o GHA Community Management, 3020 Hamaker Ct, Suite 300, Fairfax VA 22031-2220, by May 16th, 2015. If you forget you may also bring the registration form and your check by the pool the first time you come to the pool! Note: Even if you filled out a Registration form last year, please fill out a new one.

As a reminder, summer membership is **required** if your children want to become a member of the Flippers swim team. You must become a Summer Member at the time you sign your child up to be on the Flippers (this is required by NVSL rules). If you want to register your children for the swim team please send email to fceflippers@gmail.com.
